"Meetings on 5" Level 5 Pan Pacific Perth Hotel 207 Adelaide Tce Perth The outbreak of Ebola currently devastating communities in West Africa highlights the importance of such emerging infections to local communities, economies and, by extension, the resources industries operating in affected countries.

Exercise Kulinda Afya (Swahili for "Protect our Health") is a two-hour desk-top exercise aimed at company CEOs and those with an interest in protecting communities' public health.

This exercise is an element of the infectious disease risk assessment and management (IDRAM) initiative. IDRAM is part of USAID's Emerging Pandemic Threats Program which aims to identify and prevent, the spread of emerging infectious diseases from animals to humans.

The exercise is designed to help delegates consider how the resources industry can better deliver its duty of care to employees and the communities in which they operate, by helping them plan to counter the challenge of new and emerging diseases.


Around 75% of new diseases affecting humans are believed to originate in animals.

These diseases, such as Ebola and SARS, present a risk to resource companies as they and their surrounding communities push further into animal habitats.

A desk-top exercise is an activity designed to help organisations develop their crisis management or business continuity tools.



This Exercise - designed by experts from Public Health England, International SOS, Chatham House, FHI360 and USAID – will give delegates the chance to work together in small groups to think about how they would deal with the challenges presented by a disease outbreak. During the exercise delegates will work together in small groups. You will be provided with a realistic, fictional scenario about a disease outbreak and be given the chance to discuss how you would respond to it. Medical experts from the organisations that have designed the exercise will be available to assist
