Mines General Summary

GENERAL NEWS FOR AFRICA

West African Resources Limited updated on the Active, Construction Started stage asset, Kiaka: In April 2024, West African reported that it has commenced surface grade control 130,000-m drill program in March 2024 at Kiaka. (West African PR Apr 16, 2024). Announced a transaction for Sandbox Royalties Corp. to buy 10 Precious and Base Metals Royalties for \$M 90.0 on 06/06/2024.

Orezone Gold Corporation updated on the Active, Expansion stage asset, Bombore: In June 2024, Orezone started mining at Siga East and planned to commence mining in December 2024 quarter at Siga South. Also, the company planned to commence infill grade control drill program in September 2024 quarter at Siga South. (Orezone PR June 12, 2024).

Fortuna Silver Mines Inc. updated on the Active, Operating stage asset, Yaramoko: In May 2024, Fortuna reported that the Yaramoko reached the one million oz Au pour milestone on May 19, 2024. (Fortuna PR May 22, 2024).

Turaco Gold Limited updated on the Active, Reserves Development stage asset, Afema: In June 2024, Turaco completed 22holes metallurgical DD program for 3,600-m at Afema. (Turaco June 5, 2024)

Lindian Resources Limited updated on the Active, Feasibility Started stage asset, Kangankunde: In late June 2024, Lindian expected to release results of the stage 1 feasibility study and maiden reserves at Kangankunde. (Lindian PR June 12, 2024).

Aura Energy Limited updated on the Active, Construction Planned stage asset, Tiris: In June 2024, Aura was preparing for a decision to start mining at Tiris in late 2024 or early 2025. (Aura PR June 3, 2024). An Initial Capital Cost of \$M 230.0: Front end engineering study for the Tiris project updating the technical and financial parameters of the 2023 enhanced feasibility study. (Aura PR Feb 28, 2024)

Aura reported updated FEED economics with the new offtake pricing results in a significant increase in revenue of \$41 million and increases the NPV8% to \$388 million from \$366 million. IRR also increases by 2% to 36%. All other inputs into the FEED economics remain unchanged. (Aura PR Apr 16, 2024)


